SMOKING POLL

While this space is usually reserved for spotlighting *High Times* polls, this month we're focusing on a *Wall Street Journal/NBC News* survey that really captures the American public's stance on pot—which is sharply at odds with US Attorney General Jeff Sessions's outdated and nonsensical war on weed.

The survey asked, "Which substance would you say is the most harmful?" and listed tobacco, alcohol, sugar and marijuana as options.

Only 9 percent of respondents thought pot was the most dangerous substance, while a whopping 21 percent identified sugar as the most harmful. Unsurprisingly, a plurality of respondents considered tobacco to be the most harmful, with 41 percent of the vote. Alcohol finished second (and just slightly above sugar), with 24 percent.

Perhaps America is coming to terms with its serious sweets problem. When the same question was asked in 2014, only 15 percent of respondents felt sugar was the most harmful substance.

The survey also revealed that 60 percent of Americans now favor legalizing cannabis-up 5 percent from 2014.

Siri found me a head shop, and I bought a little one-hit pipe and some rolling papers, but didn't know enough to get a shredder so when I followed the YouTube how to, it was a shred by hand task.

REEFER RECOVERY

I've thought about writing down my thoughts for the past 21 months that I have stayed clear from opiates, benzos and amphetamines as a whole. I've had time to reflect and grow as a person for almost two years.

When I was young, I gravitated towards altering my state of mind. I remember tearing my MCL when I was 13. This was the first time I was introduced to hydrocodone. I remember, most vividly, the first time I actually felt the high through the pain and saying to myself "this is how life should feel." to buy pills or stealing them from the medicine cabinet.

I gravitated towards downers to help self-medicate. I would do anything to put a brief pause on the chaos that is my reality. I ended up trying heroin after being very experienced with opiates. I would rationalize the decisions I was making. I lost everything very gradually. I left my university, was ostracized from all of my social and extracurricular endeavors. I was kicked out of my house, I lost a relationship with a girl that I loved, and I lost all of my possessions. The worst things I lost were my sanity, dignity, self-respect and sense of identity.

The hardest thing to deal with was not the pain I endured, but the pain I caused. By the grace of my family I was fortunate enough to go to a treatment center in Palm Springs, CA.

As soon as I started the program I was dedicated to leaving drugs, except cannabis. I said from the start that the research in cannabis seemed promising and I believed

Mary Jane could redeem me. Only one person believed in me, the resident MD.

After leaving, I immediately obtained my medical cannabis card in the state of New Mexico where I live. I started growing my own medicine and overall I have grown [as a person] immensely.

Cannabis gave me my life back. It brought the passion back in my life. I have returned to school and will be graduating in December of this year. I am happy, healthy and clean from all of these heinous substances. I have found solace and success in daily cannabis use, and the very occasional use of LSD.

Even the co-founder of Alcoholics Anonymous [Bill Wilson] used LSD to help in his recovery. It seems that this has been lost throughout the futile War on Drugs. AA became a lifestyle preaching pure abstinence, not only from the drugs but the lifestyle that comes with the drug use. Twelve-step programs have adapted a D.A.R.E.-esque approach to recovery.

I have decided to write this as a message to all the addicts in the same position I have been in. They are not alone and you can be clean with cannabis.





TYSON **GOT A POT** FARM!

FEDERAL CRACKDOWN THE HEAD OF THE US DEPARTMENT OF JUSTICE HAS

QUASHED OBAMA-ERA TOLERANCE FOR STATES WITH LEGAL CANNABIS. PRO-WEED POLICY-MAKERS ARE NERVOUS-AND DEFIANT. BY MIKE DIPAOLA

THE ATTORNEY GENERAL of the United States has said crudely uninformed things about cannabis, even before he became the nation's highest law-enforcement official. Jeff Sessions has declared that "good people don't smoke pot," that he thought a pair of murderous Ku Klux Klansmen were "okay, until I found out they smoked pot" and that weed is as bad as heroin. While these lunacies made everybody nervous, it was not until Sessions put the kibosh on Obamaera rules-which basically said the feds would not interfere in states where

cannabis is legal-that the AG caused real alarm in the pot-positive community.

While California was celebrating the first days of its legal weed market for adults, Sessions dropped a memorandum on the nation that wafted over the land like a stink bomb. "In deciding which marijuana activities to prosecute under these laws with the Department's finite resources, prosecutors should follow the well-established principles that govern all federal prosecutions," Sessions wrote. In other words, federal prosecutors might start enforcing their dinosaur

cannabis laws, even in states where weed is legal. That would be most of the country, where 29 states plus the District of Columbia have some degree of legalization, with more poised to join the club.

The Sessions memo inspired immediate backlash: Governors, attorneys general, **C**ongress members and many others expressed dismay at the fed's implicit threat and an appreciation for the sanctity of states' rights. Senator Lisa Murkowski (R-AK) issued a pointed statement that typi-

fied much of the reaction: "Over the past year I repeatedly discouraged Attorney General Sessions from taking this action and asked that he work with the states and Congress if he feels changes are necessary. Today's announcement is disruptive to state regulatory regimes and regrettable."

Fellow Republican and Colorado Senator Cory Gardner was not as polite. "This reported action directly contradicts what Attorney General Sessions told me prior to his confirmation," Gardner tweeted. "With no prior notice to Congress, the Justice Department has trampled on the will of the voters in CO and other states." The US Attorney in his state, Bob Troyer, said his office would continue to prosecute "those who create the greatest safety threats to our communities around the state"-that is, *illegal* dealers. Put another way, Sessions's memo was unnecessary and can be effectively

巜 ignored.

While "crackdown" was on everybody's mind in the days following the Sessions memo, the cannabis-data-analytics firm New Frontier Data released an exquisitely timed study that put in stark terms what was at stake: \$132 billion in tax revenue and over a million new jobs across the United States. That's what's predicted for the next decade if cannabis is legalized nationwide, put in language that even the staunchest conservative reactionary can appreciate: jobs and money.

Paradoxically, Sessions's decree may end up accelerating the pace of legalization rather than subverting it as he'd intended. His tyrannical stupidity has alarmed many, but it has also mobilized policy-makers gearing up to terminate the US War on Drugs once and for all. "Not only are we fighting back, but we're moving forward," declared Representative Barbara Lee (D-CA) in announcing a proposed bill to legalize it at the federal level. Lee, along with co-sponsor Ro Khanna (D-CA), recently unveiled the House version of the Marijuana Justice Act, the Senate bill introduced by New Jersey Senator Cory Booker last summer.

[Sessions's] tyrannical stupidity has alarmed many, but it has also mobilized policy-makers gearing up to terminate the US War on Drugs once and for all.

The bill would end federal cannabis prohibition, with a particular emphasis on addressing the profound injustices inflicted on minorities in the failed Drug War (see NORMLizer, p. 126).

Sessions may have harshed our buzz, but he hasn't killed it. The ink on his ill-advised memo was barely dry when the Vermont Legislature went ahead and made the Green Mountain State a little greener, passing a bill that will allow adults to grow and possess modest amounts of cannabis, effective July 1.

Likewise, a changing of the guard in New Jersey augurs well for the cause. The deposed outlaw Jersey whale, ex-Governor Chris Christie, has been replaced by weed-friendly Phil Murphy, who made legalization a goal for his new administration in its first 100 days. This *nj.com* headline from Christie's very last day in office reveals a giddiness at the prospect: "New N.J. weed bill: You might be able to buy sooner AND grow pot at home" (emphasis theirs). Even New York, birthplace of the loathsome Rockefeller drug laws that destroyed so many lives, is making the right noises about cannabis. Governor Andrew Cuomo is calling for a feasibility study to at least look at legalization, in particular how legal regimes play out in neighboring states. In announcing the plan, Cuomo acknowledged the curious moment of conflicting forces in the country. "New Jersey may legalize marijuana. Massachusetts already has. On the other hand, Attorney General Sessions says he's going to end marijuana in every state," Cuomo said.

As odious and unnerving as it is to have someone like Sessions at the helm of federal law enforcement, Americans should take heart that the backlash to his words has been both bipartisan and vociferous. We do need to be vigilant, and we should be encouraged that the government still staggers along, somewhat like a democracy. Let's not let the troglodytes win.

TASTING TOURS Cannabis-tasting tours are proliferating, especially in Colorado and California. Geared to cannabis connoisseurs, pot-tourism activities have increased due to high demand. One company seizing this opportunity is Cultivating Spirits in Colorado. Its offerings include farm-to-table-style gourmet dinners prepared by an award-winning chef, limo rides and a host who vividly explains the different strains encountered and their benefits. The company's goal is to change perceptions of cannabis and to glamorize weed's image.



CANNABIS CURRICULUM What started with pot-based specialty schools like Oaksterdam University has carried over to institutions of higher learning, as schools respond to the booming cannabis industry. The University of Denver now offers three cannabis-related courses. And Northern Michigan University students can now major in marijuana (technically medicinal-plant chemistry), the first-ever four-year undergraduate degree of its kind offered anywhere. Niagara College also offers a one-year postgraduate program on the production of pot-the first Canadian college to do so.





DIGITAL HEADSHOPS For better or worse, the davs of brick-and-mortar headshops are on the wane. As cannabis continues its assimilation into the mainstream, online marketplaces are cropping up to meet all of your smoke-related needs. Often, these online shops promote a classier boutique image, catering to the cannacurious. Products include smoking accoutrements like bongs, rigs, pens and pipes, as well as vintage art pieces, ceramic stoneware. aromatherapy products and much more. Subscriptions are available with delivery to vour home.



DIVERSITY

Compared with other sectors, the cannabis industry has a high level of gender diversity. Women fill executive positions in 36 percent of US companies focused on cultivation and 63 percent of testing labs and processing companies. A good start but there's certainly room for improvement. By comparison, women hold senior management positions in only 22 percent of midsize US companies and a paltry 5.4 percent of CEO jobs at Fortune 1000 companies according to a 2015 Pew Research study.



JOURNALISM Pot iournalism is thriving and covers every nook and cranny of an industry on the rise, thanks to the proliferation of adult-use and medical-cannabis laws across the country. For years, the mainstreammedia coverage of cannabis was laden with misinformation, highlighting the need for strong and independent marijuana iournalism. Resources are now being dedicated to activist-centered publications that have an interest in the plant and the people affected by the War on Drugs.

WICKED COOL COPS

While the current administration in Washington, DC, is signaling a possible crackdown on legal-weed states, soon-to-be-legal Massachusetts says it won't lend a hand if the feds try to shut down law-abiding weed businesses in the Bay State. Boston Police Department spokesman Detective Lt. Michael McCarthy told the Herald that the men and women in blue would respect state rights over federal meddling. "Similar to our position on immigration, the BPD will not actively enforce federal marijuana laws at the local level," McCarthy stated. "We will continue to enforce local drug laws to keep our neighborhoods safe." Public safety secretary Daniel Bennett, who oversees the state police, seconded that motion: "We have a state law that we're intending to enforce, and the state law was voted on by the people of Massachusetts. We have no intention of raiding a pot shop that is legal under state law."

KANSAS REP'S RACIST RANT

When we hear dinguses try to argue against weed legalization, what we usually hear is antiguated and anti-scientific posturing based on nothing. But sometimes a dingus will bring extra stupid to the table, as when Kansas State Representative Steve Alford was musing extemporaneously and idiotically at a public meeting about why cannabis was prohibited in the United States in the first place. "One of the reasons, I hate to say it, the African Americans they were users and they responded the worst to all those drugs-it was because of their character makeup, their genetics and that." After his remarks were posted on YouTube, and following the well-deserved tsunami of ridicule heaped upon him, Alford abjectly apologized: "I was wrong, I regret my comments, and I sincerely apologize to anyone whom I have hurt." He was also stripped of his committee posts, though he keeps, for now, his seat in the State Legislature.

INSIDE THE WIDE WORLD OF WEED

SNOOP IN THE BOX

Snoop Dogg has many irons in the fire at the moment. His cannabis-lifestyle media company Merry Jane recently teamed up with fast-food purveyor Jack in the Box to create a meal fit for a stoner—the Merry Munchie Meal. Intended to celebrate the opening of California's adult-use market, the limited-edition food box was part of the restaurant chain's late-night menu, priced at an easy-to-remember \$4.20. The grub included curly fries, onion rings, tacos, mini churros, chicken strips and a soft drink. "Launching the Merry Munchie Meal is the perfect way for both companies to celebrate legalization in our shared home state of California," said Scott Chung, chief operations officer of Merry Jane. Although the meal was available for a limited time at just a few Jack in the Box locations in Southern California, its popularity will likely inspire others to cash in on a universal truth: Stoners gotta eat.



CHRONIC PAINKILLER

A very tall man in the United Kingdom was busted for growing 20 plants in his Burnley, Lancashire, home. Sixfoot-eight Omar Anwar copped to the crime, telling a magistrate that he suffered from gout and chronic back pain that he attributed to his height, and that he preferred homegrown meds to buying it off the street. The 29-year-old was sentenced to a year's probation, 150 hours of community service and some modest court fines. Even the prosecutor was sympathetic, according to the *Burnley Express*: "He feels quite strongly for the decriminalization of cannabis for medicinal purposes,

because that is the only reason he was intending to use this drug. He's an intelligent and articulate gentleman who is deeply ashamed to find himself before the court for this matter." For his part, Anwar was contrite, perhaps excessively so. "I am the worst Muslim ever," he said to his probation officer. No sir, we can assure you that you are not.

The Tyson Ranch will include an extraction facility, an edibles factory and a hydro-feed supply store, as reported in the Blast. Iron Mike made no secret of his fondness for cheeba during his boxing career, which sometimes cost him dearly. In 2000, his knockout win over Andrew Golota was rescinded when Tyson tested positive for cannabis. Today, Tyson is positive that his ranch is going to be a knockout. "We're going to have the best marijuana around, so I'm not worried about the competition," he said. When asked if he planned to bring in other celebrities to lend their names to the operation-such as Snoop Dogg, for example-Tyson replied: "There's always the possibility; Snoop and me are good smoking buddies."

MISIONTED

At first, marijuana-advocate icon Steve DeAngelo was happy to be parodied on the Netflix stoner series *Disjointed*—a comedy that revolves around the shenanigans attendant to working at a California weed shop. DeAngelo, co-founder of Oakland's legendary dispensary Harborside, is spoofed by a *Disjointed* character known as "Angelo DeStevens," who, unlike the real-life activist and medical-pot champion, is kind of a dick—a sexist, greedy sellout. "I was entertained by the first episode the DeStevens character was in, but my feelings were hurt by the mean-spirited episodes that followed," DeAngelo tweeted, moments later adding, "I don't feel I deserved the treatment they gave me in later episodes—so many more worthy villains in the world." *Disjointed* has been popular with viewers but largely shunned by critics, who collectively give the comedy a 23 percent rating at *rottentomatoes.com*. There's no word yet on whether the show will re-up for a second season.



COLD DANK FINGERS

As Pennsylvania's medical-cannabis era begins, citizens have state agencies in their corner. The state's Department of Health announced it would not share the names of medical-pot patients with law enforcement, in part to protect their Second Amendment rights. (With weed still illegal at the federal level, stoners and patients have difficulty purchasing firearms.) Pennsylvania's first dispensary opened in Bethlehem in January, and the owners gave props to their state overlords: "Pennsylvania and the Department of Health has been doing it right," Victor Guadagnino Jr., co-founder of family-owned Keystone Canna Remedies, told *NBC10*. "The state is setting the standard for how other states should implement medical-marijuana programs." It helps that the Keystone State has an advocate in its attorney general, Josh Shapiro. "It's my job to uphold the law here in Pennsylvania; and on a bipartisan basis, the Legislature passed and the governor signed a medicinal-marijuana law that is very popular," Shapiro told *KDKA-TV*.



GREENER MOUNTAIN STATE

Nine. That's how many US states have freed the weed. The most recent to join the party is Vermont, which just enacted a limited form of legalization, allowing adults 21 and older to possess up to an ounce of weed and grow a couple of plants at home. Buying and selling in a free and open market might not happen anytime soon, however. Governor Phil Scott, who signed off on the bill, is not exactly pro-weed. He has been insisting that any broader pot legislation will have to address education, prevention and highway safety. "To be very direct: There must be comprehensive and convincing plans completed in these areas before I will begin to consider the wisdom of implementing a commercial 'tax and regulate' system for an adult marijuana market," Scott said following the signing. "Until we have a workable plan to address each of these concerns-I will veto any additional effort along these lines."

One Saturday-night event took place at cannabis hotspot Hitman Coffeeshop, in the heart of Los Angeles. Infused cocktails and snacks were served as Goldberg oversaw the evening with the help of some budtastic friends: Emily O'Brien of Mondo Meds was presiding over a medicated cotton-candy station, and cannabis matchmaker Molly Peckler of Highly Devoted was on hand to dispense dating advice to lonely hearts. Party favors were given out to guests in the form of tiny glitter-dusted doughnuts, each containing two milligrams of THC.

A few partygoers sported all three. Making friends is much easier if you're open to meeting all kinds.

"IT COULD BE their sister or something."

"No, when we found your grandparents they were in way bigger boxes than that."

Mike Abbate ("King Mike") and Marissa Paternoster, respectively the bassist and guitarist/vocalist of Screaming Females, are discussing a tiny labeled box they have discovered in a studio in New York's Chinatown, where the band has congregated to spend a snowy afternoon chatting with High Times. Closer inspection reveals the cube to contain the ashes of the studio owner's cat. The pair are unperturbed. Abbate smiles as he remembers finding the shoebox-size coffers that held the remains of his ancestors "in the back of a closet."

"We went and got screwdrivers," Paternoster recalls, "and I was like, 'Mike! It's cat litter!" She was elbow-deep before Abbate read the label on *that* box; a quick trip to the sink followed.

Quirky and wild, like the New Jersey band's music, the story illustrates both the easy camaraderie among the trio—Paternoster, Abbate and drummer Jarrett Dougherty have been friends since their teens—and their unfettered interest in exploration. That interest is evidenced by their musical progression over the past 13 years, culminating in *All at Once*, their seventh album, which dropped in February.

"We were trying to incorporate different sounds or use different instruments than we would in the past," explains Paternoster. Some of those sounds include that of keys being dropped on a paint bucket and pots being banged together, a noise that producer Matt Bayles decided to strip directly from the demo, to stop Paternoster from driving Abbate insane by "testing" pots in the kitchen while he was trying to cook.

The band recorded the album in a Seattle suburb where, Abbate explains, "there was literally nothing to do but get high." Though today Abbate is the heaviest, and often the only, smoker in Screaming Females, he and Paternoster smoked weed together for the first time in high school. "We didn't get high, but Marissa acted really high," recalls the bassist.

"I thought I was!" Paternoster defends herself.

"She was driving us home

and she was like, 'This is so much better than, like, you know, dealing with life, maaaaaaan.' I was like, 'Really? I feel the same [as before I smoked].'" Abbate laughs.

Though they'll occasionally place a sign on their merch table asking fans for weed ("It only works on the West Coast." sighs Abbate), the band never carries it in the van. Still, they look like they carry it, and that has led to some holdups on the road. Dougherty recalls a night spent at a fan's house in Arizona before Prop. 203 passed. "He busted out this bong, and just smoked it for hours," while the band was trying to snuggle down for the night in their sleeping bags.


"The next day, we hit one of those border checkpoints," Dougherty says. A dog was brought to the van and, to the band's alarm, seized Paternoster's sleeping bag and began "shaking it to pieces on the highway." The band was eventually released, but not before being asked if they "could've been somewhere where someone had drugs." Dougherty shakes his head. "We're a rock band—we've been sleeping on people's floors for three weeks playing shows!" He laughs. "Not a chance we've been anywhere that anyone's been using drugs." 🖗

is peeking past his pupils, wanting to play and take over the conversation. It's the same look he has onstage when he's revealing the things he does in real life and that we secretly love to do ourselves: "Is there anything more satisfying than letting an elevator door close on somebody?"

Segura muses: "[We're] living in such an unequal world right now. The power is not in most people's hands. And that's one of those fleeting moments you have control over. Like someone crossing the street slowly, and they know they're doing it slowly. You're being an asshole, but if you don't have any power then you're gonna take the moment you have. It's not gonna hurt anybody, you're not actively destroying you're taking a moment to say, 'I have control in the moment.''

It's that type of acute awareness that makes it easy to listen to Segura talk forever, but he has to go sign posters from his sold-out Netflix taping in Denver. Before we wrap up, though, he offers one last piece of advice: "Don't take an edible on a flight to Australia. I wept. This is a 16-hour flight, and I'm like, 'I'm gonna die, dude.' It was way too strong. That's why I stick to pens!"

We laugh and shake hands. It's a perfect callback to our shared joy of using pens. It's also a testament to Tom Segura's stand-up abilities, and it shows how keenly aware he is of when one moment (our conversation) is over, and it's time for a new one to begin. &

COMIC TOM SEGURA LOVES HITTING VAPE PENS AFTER DESTROYING

AUDIENCES AROUND THE WORLD. BY MIKE GLAZER

THE FIRST THING you notice when Tom Segura walks into the room is how present he is. He's letting it *all* sink in. Assessing the vibe, seeing who's around and checking in with himself. It's quick, but it's there. He's keenly aware of the moment.

This natural awareness and ability to be present is why Segura is such a killer storyteller onstage. His masterful ability to absorb and recall exactly how a wild moment in his life went down, and share it with us in crisp, vivid, side-splittingly funny detail, is the hallmark of his three Netflix specials (*Completely Normal, Mostly Stories* and his latest, *Disgraceful*).

(Side note: Storytelling is fucking hard. You've probably had to listen to someone talk about a "wild" party they were at, and in your head you're thinking, "Hey, shut up. This is boring and bad, and I wasn't there so I don't care.")

Telling a great story takes craft, and the ability to make

almost 2,000 paying audience members erupt in laughter as a single voice took Tom almost 14 years to master. He leads us into his past so that we relive moments with him: the good ones, the bad ones, even the ones you would never tell a room full of strangers-check out his bits on *Disgraceful* about seeing a racist fight break out in Philadelphia. Or when he bought porn for his entire dorm, and found himself in a cement building with a glory hole. Or the time he was buying weed from someone in a trailer and wound up with a shotgun and direct orders to shoot anyone except for the dealer's mom (luckily, he doesn't buy weed from people inside trailers anymore).

As we sit down to chat, Segura immediately starts talking about his love for getting high using pens.

"I travel with pens. People go, 'Is that legal?' I don't fucking know, but no one bothers me," he says. "Pens are my favorite. I'm cool with having nothing but pens for the rest of my life. I perform 100 percent sober, but after a show I like a quick hit to chill. I actually prefer it to a postshow drink."

Again, for Segura it seems to be all about staying in the moment. Smoking something low-key enough that it smooths the edges and travels underneath the mind. Nothing out of control. Nothing over the top—instead, something that brings him to a centered state of being. Something that adds to the experience instead of dramatically altering it.

While we talk, Segura is softspoken and kind, but there's a powerful, almost mischievous glint in his eyes. It's as if a child

Extensive research has shown that CBD can benefit users in myriad ways, treating depression, anxiety, epilepsy, pain and a wide array of other conditions and disorders. However, federal law—and the stigma surrounding marijuana—often restricts patients' access to the life-changing substance. Shira Adler's book, *The ABC's of CBD*, cuts through the misinformation, answering questions about CBD with simple facts and a cheery tone. What is it? Where does it come from? How, exactly, does it work?

Adler emphasizes right off the bat that she knows the subject well, writing, "I live, breathe, sleep, research, and, yes, ingest CBD every single day." A proud parent of two, she addresses giving CBD to

Adler includes interviews with industry professionals and medical-cannabis patients, including Jocelan Carmichel, a nurse who credits CBD with helping her treat (and beat) breast and bone cancer. A guide to news and resources, with a list of books, websites and fact sheets, closes out this helpful little primer.

If you're curious about cannabidiol, *The ABC's of CBD* is a great starting point to learn about its many wonders. Adler pays homage to the ancient wisdom of the herb, with plenty of facts and statistics to back up its healing power. *Mary Jane Gibson*



When South Park: The Stick of Truth was released in 2014, it capped off five years of troubled development before the game was rescued by Ubisoft. HILE THE FIRST months of 2018 have seen the opening of California's adult-use market and wide-ranging speculation about what US Attorney General Jeff Sessions's rescission of the Cole Memo would mean to the cannabis industry nationwide, July 1 will soon draw attention to our neighbors in the north.

Some of the finishing details are yet to be worked out (most of the rules affecting consumers have been left to each of Canada's 10 provinces and three territories to determine), and most Canadians are not expecting a finished product on day one. Law- and policymakers are still trying to define regulatory models, so it will take some time for the environment to fully take shape. New Frontier Data has provided input to Canadian regulators regarding some effective regulatory structures.

Most observers are expecting it to take one or two years for the dust to settle. But that's okay for those welcoming a legal market that is projected to eventually yield billions in profits and revenues, even if 2018 will be more of a historic landmark with less of the earning milestones that are sure to be seen down the road as the program and markets mature.

Early signs are encouraging. As of January 1, 2018, there were 84 licensed producers in Canada, up from 59 in 2017 (a 42.4 percent increase). The country's total market forecast (from both legal and illicit sales) falls somewhere between C\$9.5 billion to C\$10.5 billion (US \$7.6 billion to US \$8.4 billion), making Canada's market comparable to California's. Meanwhile, the start of 2018 also saw an estimated 58 cannabisrelated stocks listed on the Canadian Securities Exchange.

Such profit potential has drawn the attention of plenty of investors. In October 2016, Constellation Brands raised eyebrows and enthusiasm as the major US wine and beer distributor invested \$245 million in Canopy Growth, owner of several licensed medical-marijuana growers in Canada.

Though the country first legalized medical cannabis in 2001, Health Canada reported how eligible medical enrollees were increasing by 10 percent a month as of May 2017. By September, there were 235,621 medical patients being supported by licensed producers (who provide roughly half of Canada's medical cannabis, with home producers supplying the rest).

That noted, it is on the export side where most analysts expect the market to thrive. Among notable countries where Canada is exporting medical cannabis are Germany, Brazil, Australia, New Zealand, Chile and South Africa.

Were Brazil to legalize medical cannabis (South America's largest nation allows CBD, but not cannabis), the number of patients in the first three years could reach 959,000 even with a relatively restrictive list of qualifying conditions (i.e., not including chronic pain). The 2016 Global Health Disease Study found that one in five adult Brazilians suffer from lower-back or neck pain. Should chronic pain be included as a qualifying condition, as many as 3.4 million patients would translate to a projected R4.4 billion (US \$1.4 billion) in annual revenue.

As announced in January, a Canadian medical-cannabis exporter signed for an undisclosed amount to supply Germany's CC Pharma GmbH with products to distribute through more than 13,000 German pharmacies. Toronto-based producer Nuuvera (a strategic partner with Aphria) designed a one-millionsquare-foot greenhouse to supply 1,200 kilograms of medical cannabis to CC Pharma.

Overall, Canadian medical cannabis will be available for sale in most of Germany's 20,200 pharmacies due to deals inked in 2017. 🔆



AN IN-DEPTH LOOK AT CANNABIS BEYOND JUST THC AND CBD. BY NICO ESCONDIDO

IN THE BEGINNING

In 1964, two young scientists, Dr. Raphael Mechoulam and Dr. Yechiel Gaoni, were the first to isolate and map the molecular structure of THC. This cannabinoid is, of course, the primary and only psychoactive chemical compound found in cannabis.

Late in 2010, this author had the pleasure and privilege to interview Dr. Mechoulam at his laboratory at the Hebrew University in Jerusalem. During that interview, I asked him a simple question: Why cannabis? And his answer was simple as well. In short, Dr. Mechoulam was interested in "natural products" that could elicit a therapeutic response within the human body. And while other plants, such as coca and poppy, had already been refined for medical purposes—cocaine in 1860 and morphine in 1803, the latter being believed to be the first isolation and extraction of an active compound from a plant there was not an overabundance of options left. So "Why not cannabis?" Dr. Mechoulam asked in response.

Less than a year after my interview with Dr. Mechoulam, another prominent scientist, Dr. Ethan Russo, published an equally important piece of research in the *British Journal of Pharmacology*, "Taming THC: Potential cannabis synergy and phytocannabinoidterpenoid entourage effects." Dr. Russo is a board-certified neurologist, former senior medical advisor to GW Pharmaceuticals and a widely published author in many scientific journals, books and periodicals (including our very own *High Times*).

Building off of the previous work and ideology of Mechoulam and Gaoni, Dr. Russo introduced the next steps in our collective understanding of the effects and benefits of marijuana, this time focusing not just on cannabinoids, but also on the terpenoid content present in the plant. Both the isolated effects of other cannabinoids (such as CBD, CBG, THCV, etc.) and terpenoids as well as the sum of all parts when taken together, he argued, represented "another echelon of phytotherapeutic agents."



WHAT (EXACTLY) ARE TERPS?

Before we get back to Dr. Russo's work and attempt to more fully understand the interactions between terpenes and cannabinoids (i.e., the entourage effect), we first need to know just what exactly "terps" are. Technically speaking, terpenes are a large and very diverse class of organic compounds (hydrocarbons, to be exact) that are produced by a wide variety of plants, including cannabis.

Some authors use the term "terpene" as a broader, catchall phrase that includes the subgroup known as "terpenoids." Terpenoids can be thought of as modified terpenes, although they are very similar in most aspects aside from molecular structure. Terpenoids



are terpenes that have been chemically altered, usually in the form of a moved or lost methyl group (one carbon plus three hydrogen atoms, or CH₃). More important, terpenoids are also terpenes that have become denatured by oxidation, such as during the drying and curing of buds, making "terpenoid" a more accurate term when discussing strains that are ready for smoking, whereas "terpene" is more accurately used when discussing live plants (or fresh frozen plants, for extraction purposes).

A much simpler way to look at terps is that they are a plant's "essential oils," or the primary building blocks of any plant resin, and they are largely responsible for the scents, flavors and colors of plants. There are over 200 known terpenes in cannabis and, by comparison, just over half as many known plant cannabinoids (113), which are 21-carbon-atom molecules found only in cannabis and are completely odorless. And while Dr. Russo's research strongly suggests that terpenes can contribute to the overall effects of cannabis, either singularly or via the total compounded effects of all cannabinoids and terpenes, there are no known psychoactive effects from individual terpenes.


It is also worth noting that terpenes are created through the biosynthesis of isoprene units, which are carbon and hydrogen building blocks (C_5H_8) for terpenes. This is important because it leads to that long and diverse list of organic compounds that encompass what a terpene can be. Adding a prefix to the name indicates the number of isoprene

units needed to make that type of terpene, because for each single terpene involved there are two isoprene units needed.

For example, when you see the term monoterpene ("mono" meaning one), you know there are two isoprene units involved. Similarly, sesquiterpenes ("sesqui" meaning one and a half) indicates there are three isoprene units, and diterpenes ("di" meaning two) indicates there are four isoprene units, and so on. The list continues up to tetraterpenes, meaning eight isoprene units. After that, the terminology is generic, with polyterpenes indicating many isoprene units (i.e., more than eight). Just like terpenes, terpenoids can also be classified according to the number of isoprene units used. This is important because this is how scientists are able to identify and elucidate individual terpenes or terpenoids within a plant sample.

Lastly, terpenes, like cannabinoids, are synthesized in cannabis inside secretory cells that exist within the plant trichomes, which cover buds and leaves. Trichomes are most concentrated on unfertilized female flowers during peak flowering-usually around the six- or seven-week mark, just as trichomes begin to turn amber in color. Being created within the same physiological structure is important because it shows us that both cannabinoids and terpenes share a common denominator, or precursor, in their production: geranyl pyrophosphate. This could suggest common receptor potential within the human body for both cannabinoids and terpenes, a basis for the research of Dr. Russo.

THE RUSSO PAPER

By the time Dr. Russo took up his cause to explore the potential synergetic effects of cannabis terpenes alongside cannabinoids, most of the prominent cannabinoids had already been elucidated, most of which by Dr. Mechoulam beginning with cannabidiol (CBD) in 1963 and then the seminal discovery of THC in 1964.

But in 2011, Dr. Russo set out to investigate the effects, if any, of the various terpene profiles found in cannabis. Either alone, or in conjunction with one another, or in totality along with the cannabinoid profiles found in strains, Dr. Russo hypothesized that terpenes and flavonoids could elicit therapeutic responses within the human body and contribute to the effects of the cannabis plant. At the time, only one previously manufactured pharmaceutical, Sativex, had been synthetically derived from the plant's chemical structures (THC and CBD in a 1:1 ratio), and since then, only one other, Marinol (synthetic THC), has come to market. While Sativex has seen moderate success and gained approval for use in over 30 countries, including the United States (where it is called Nabiximols). Marinol has not enjoyed as much success, though it was approved by the Food and Drug Administration (FDA) in the US. Still, neither Sativex or Marinol was able to reproduce the same medical and therapeutic effects that one receives when smoking the actual plant. The "full bouquet," so to speak, of a particular strain offered something to patients that a single—or even a pair—of cannabinoids could not. Clearly, more research was needed, and Dr. Russo had an idea where to look.

In the past, various researchers had attempted to uncover the mysteries surrounding terpenes, emphasizing their pharmacological importance. Aromatherapy, a form of holistic healing, has been a popular method for healing for centuries. And in 1998, Dr. Mechoulam even co-authored a paper with Dr. Shimon Ben-Shabat that suggested biological compounds created by the human body, known as endocannbinoids, might act in concert with other compounds to exert what they coined an "entourage effect." Dr. Russo looked at this term and applied the same concept to his own research, except in his studies he substituted the endocannabinoids of the human body with the actual phytocannabinoids produced by the plant itself, leading to theories about the synergistic effects that terpenes and cannabinoids might have when combined with each other.

RELATED SCIENCE: THE ENTOURAGE EFFECT

Around the same time that Russo was doing his research on possible entourage effects of the combination of terpenes and cannabinoids, a Swiss scientist, Dr. Jürg Gertsch, was researching similar theories. In 2008, three years prior to Dr. Russo's paper, Dr. Gertsch documented that beta-caryophyllene, a primary terpene found in a majority of cannabis strains, had a certain affinity for binding to CB2 receptors in the human body. This discovery is of extreme importance as betacaryophyllene is the only known terpenoid to directly activate a cannabinoid receptor, thereby proving that, at least on some level, terpenes do, in fact, play a role in the overall therapeutic effects of marijuana.

Dr. Gertsch's findings illustrated perfectly the theory of the entourage effect: Beta-caryophyllene, a terpene found in oregano, black pepper and other green, leafy vegetables that has been known to be good for treating certain ulcers, acting as a gastroprotector in herbal remedies, binds to CB receptors previously thought to be reserved strictly for cannabinoids and, subsequently, the body's own endocannabinoids, providing new evidence that terpenes also play a direct



role. So while this shows that the aromatherapy and herbal therapies of ancient cultures were certainly onto something, it also shows that when humans use cannabis there is a lot more going on than just reactions to THC and CBD. But what does this mean in terms of how cannabinoids such as these interact and work in concert with terpenes?

The 1998 paper by Dr. Ben-Shabat and Dr. Mechoulam put this very question to test when researchers used lab mice in a study to determine if terpenes acted alone or in tandem with cannabinoids to elicit a stronger or overall different effect. In short, they found that the naturally occurring endocannabinoid known as 2-AG (2-arachidonoylglycerol), when administered with two related compounds (i.e., esters derived from carboxylic acids, which are molecularly similar to cannabinoids), would bind more readily at the cannabinoid receptors and exert a more pronounced behavioral effect on mice.

This was, to a certain extent, proof that endocannabinoids working at the CB-receptor level could have altered effectiveness when used in conjunction with other compounds. A few years later in 2001, Dr. Russo and Dr. John McPartland would publish a paper in the *Journal of Cannabis Therapeutics*, stating, "Good evidence shows that secondary compounds in cannabis may enhance the beneficial effects of THC and reduce THCinduced anxiety, cholinergic deficits, and immunosuppression."

Dr. Mechoulam himself would later address these findings, saying, "Very seldom is



the biological activity of the active constituent [analyzed] together with inactive 'entourage' compounds. Investigations of the effect of the active component in the presence of its 'entourage' [non-psychoactive] compounds may lead to results that differ from those observed with the active component only." Essentially, Dr. Mechoulam was stating that while scientists previously were focused only on the active components of such natural products as cannabis, had they taken a broader approach and looked more holistically at the product, they might have found different outcomes when it comes to the effects elicited from said products.

These findings and statements by some of the most prominent and respected scientists in these fields were only the beginning in a wave of theory and research that is still ongoing. Of course, the biggest hindrance to much of this work is the fact that cannabis is still federally prohibited in the United States, which has slowed progress and is why nearly all of this referenced research was conducted overseas. Still, the work that has been done to this point gives us a better understanding of why and how different strains of marijuana elicit different effects in the user. When you think about what makes a sativa a sativa or what makes an *indica* an *indica*, there clearly has to be more involved than just the THC or CBD levels. Sure, there are other cannabinoids in varying amounts as well, but this research shows us that terpenes, and even many flavonoids, have a significant role to play as well.

THE PURITY & SAFETY OF TERPENES

Much has been made lately over the purity, quality and safety of terpenes and terpene-extraction processes. We already know that many vape-pen cartridges are adulterated with synthetic terpenes and artificial flavors. But are these terpenes safe to ingest and, more specifically, smoke? We know that terpenes share a chemical precursor with plant cannabinoids and that they are all flavor and fragrance components common to human diets. Thus, these terpenes and flavonoids have, for the most part, been designated as "generally recognized as safe" by the US FDA and other regulatory agencies.

Still, some folks out there also like to argue against the purity of terpene products currently on the market, claiming that some extraction methods-primarily through distillation-create hydrosols which, simply put, are terpenes that have been diluted by the addition of water from the distillation process. With similar therapeutic properties to essential oils, these "aromatic waters" are much less concentrated, which might not be the worst thing. Far worse than those creating hydrosols are the extract artists who knowingly and purposefully pollute dab products with non-cannabis-derived terpenes, synthetic terpenes and artificial flavors (the latter two being nonorganic). Call us purists over here at HT if you like, but we only allow cannabis-derived terps in our Cannabis Cup competitions when it comes to concentrates. If those cannabis terpenes are derived from an organic, nonchemical solvent process like steam distillation, a little H₂O in the terps is really no big deal.


As Dr. Russo put it, "Terpenoids are quite potent and affect animal and human behavior when inhaled from ambient air at serum levels in the single digits ng-mL⁻¹[Editor's note: That's nanograms per milliliter, where there are one million nanograms per mL]... and display unique therapeutic effects that may contribute meaningfully to the entourage effects of cannabis-based medicinal extracts." Basically, Dr. Russo is telling us what we already know: that terps are extremely potent, even in the absolute tiniest of amounts. So, then, what's the big gripe against hydrosols, you might ask?

Well, in this new age of legal marijuana industries—which are netting billions in revenues—there are dollars at stake and people have gone through painstaking efforts to develop (and protect) various techniques and methodologies for everything from cultivation to genetics, to recipes, to extraction methods. And when these modalities are challenged or threatened, people tend to defend their claims.

So when it comes to terpenes—whether synthetic or organic, derived from cannabis or from other sources, or are just a bit watered-down—you can decide for yourself where your preferences lie. But at the end of the day, as long as these products are organic and derived solely from cannabis, they are relatively safe and bring the user immense amounts of fragrance and flavor.







TERPS 101

Below is a list of the most predominant terpenes found in cannabis strains that have been lab-tested at our Cannabis Cups over the past five years. These terpenes are not only the most prevalent, but also the most active in terms of both isolated effects and overall entourage effects when combined with cannabinoids such as THC.

BETA-CARYOPHYLLENE

Perhaps the most common terpene, betacaryophyllene (or just caryophyllene, as it is commonly known) is present in eight out of 10 strains and has a woody, sweet, dry clove aroma. It has a spicy, almost peppery taste with hints of camphor and citrus in the background. It is a major terpene found in black pepper, clove, cotton and, in smaller amounts, green, leafy vegetables. Caryophyllene oil is an essential oil used to enhance tobacco flavor.

As previously mentioned, caryophyllene played a major role in Dr. Russo's 2011 *British Journal of Pharmacology* paper on the entourage effect due to its ability to bind directly to the peripheral cannabinoid receptor CB2. That, in and of itself, is endlessly intriguing. And because of that fact, caryophyllene shows promise in salves or lotions as a therapeutic compound for inflammatory conditions and autoimmune disorders. It does not, however, seem to be involved in mood change or have other psychoactive aspects. Lastly, and sadly, caryophyllene oxide has the distinction of being the component responsible for cannabis identification by drug-sniffing dogs.

BETA-MYRCENE

Another very prominent terpene found in most cannabis strains, beta-myrcene (or myrcene) was once thought of as a predominantly *indica* terpene due to the types of effects it elicits. However, with the recent wave of research in terpenes and strain chemotypes, it was found that myrcene is equally common in both *sativa* and *indica* varieties, casting further doubt on our taxonomical classification system of cannabis's three species.

When it comes to the interactions with cannabinoids, myrcene can be described as a "synergist" of THC, meaning that when the two molecules combine in the body a stronger experience is created than with just THC alone. Because myrcene affects the permeability of the cell membranes, it allows more THC to reach brain cells as well as increases the absorption of other terpenes. High doses of myrcene were shown to induce sleep in mice during lab trials, and this sedative activity is likely why hops and lemongrass have been used as therapeutic sedatives in herbal healing for centuries. This is also why hoppy beers as well as myrcenedominant indicas are famously known for their "body buzz" and "couchlock" effects.

D-LIMONENE

Limonene is one of the most popular cannabis terpenes, mostly due to its intense citrus aroma and sweet but potent lemonlime flavor. In certain lab experiments, it has been shown to combat and destroy breast cancer cells as well as pathogenic bacteria. Limonene's molecular structure helps it to facilitate its effects by quickly permeating the blood-brain barrier. When present with THC, this effect can aid in the cannabinoid more readily binding to CB1 receptors in the brain. Limonene has also been reported to increase alertness and restlessness in lab tests involving mice. Limonene is found in larger quantities in Chem, OG and Sour Diesel strains.

ALPHA-PINENE & BETA-PINENE

These are the two chemical structures of pinene found in nature. Pinene is used medically in expectorants and topical antiseptics. Like limonene, pinene also easily crosses the bloodbrain barrier, where it helps block chemical activity that normally destroys information-transfer molecules, thus facilitating better memory and leading to suggestions that pinene might have an application in the clinical treatment of Alzheimer's disease. Pinene is also a known bronchodilator, allowing for larger inhalations, which can help those with asthma.

LINALOOL

Linalool is a component of several sedating essential oils, including lavender oil, which is believed to possess antianxiety and sedative properties. In clinical tests on humans who inhaled linalool, the terpene caused severe sedation. In similar tests on lab rats, it reduced the rodents' motility by nearly 75 percent.

While linalool's synergistic effects alongside cannabinoids are still being investigated, the hope is that linalool might help in the treatment of several types of cancer due to its effective medicinal properties. It is also a well-known antidepressant, as it amplifies serotonin-receptor transmission. In addition to being a compound that can mediate stress, linalool is also a strong anticonvulsant and may be particularly beneficial for topical applications, specifically healing acne and skin burns without scarring.

IN THE END

We now know that there are many chemical compounds in marijuana, including cannabinoids, terpenes and flavonoids. Most of these compounds carry with them specific medicinal attributes, often combining with each other to create a holistic "entourage effect" such that the medicinal impact of the entire plant is actually greater than the sum of its parts.

Dr. Russo's research indicates that cannabinoid-terpenoid interactions "could produce synergy with respect to treatment of pain, inflammation, depression, anxiety, addiction, epilepsy, cancer, fungal, and bacterial infections." Additionally, we know that terpenes, just like cannabinoids such as CBD, can buffer THC's psychoactive effects. Conversely, we also know that certain terpenes can aid or strengthen the effects of THC. The questions now are: What exactly are the combined effects that we want to create and elicit from this plant? How do we want to create and administer these medicinal compounds? And, most importantly, when will our federal government wake up to this news and end cannabis prohibition so that research like Dr. Russo's and Dr. Mechoulam's can be conducted at universities and research institutes within our own country's borders?

The science is there and much has been proven. We have won many battles, but the war will not end until the ignorance and stubbornness abates. It appears we still have a long way to go. It's time to raise the stakes once again, and science is our biggest ally. 🕊



AS CANADA PREPARES TO LEGALIZE RECREATIONAL CANNABIS THIS SUMMER, WE CHECK IN WITH TOP POT SPOTS ACROSS THE COUNTRY TO ASK MARIJUANA BUSINESS OWNERS, WORKERS AND CONSUMERS: HOW WILL LEGAL WEED AFFECT THE CANADIAN ECONOMY AND CULTURE?

NDER PRIME MINISTER Justin Trudeau's Liberal Party leadership, Canada is set to legalize cannabis nationwide in July of this year, making it the largest country in the world to have a federally sanctioned marijuana marketplace. The True North, strong and free? That remains to be seen, say industry experts and activists across the nation.

According to a Statistics Canada report, Canadians spend almost as much on the green as they do on the grape, consuming C\$6.2 billion worth of marijuana in 2015—a relatively conservative estimate, the agency admitted, stating that actual consumption could "reasonably" be as low as half that amount, or as much as double. By comparison, Canadians spent C\$7 billion on wine in 2015.

The emerging Canadian cannabis industry has seen dizzying growth in the past year. Shares in Canopy Growth Corp. (formerly Tweed Marijuana Inc.), trading on the Toronto Stock Exchange as WEED, have more than tripled. *Bloomberg.com*

reported that the company's market value of C\$7.2 billion now exceeds that of Bombardier Inc.—the world's leading manufacturer of both planes and trains.

No matter how you slice it, the legal weed industry is guaranteed to be a huge payday for the Canadian government, with an estimated \$400 million generated annually in taxes from retail sales, according to *Bloomberg*. And cannabis businesses across the country are clamoring for their share of the pot pie.

SHOULD LEGAL WEED LOOK FUN?

Government regulations and restrictions on legal cannabis sales may limit the retail weed market to some degree. Cannabis-product packaging may be required to display health warnings akin to the graphic images of smoking-related diseases that are printed on packs of Canadian cigarettes. Consumer testimonials may be banned. Ditto for celebrity endorsements. Packaging could be mandated to look as plain and unglamorous as possible if officials have their way: no bright colors, fun fonts or trippy designs.

In a 2016 report titled "A Framework for the Legalization and Regulation of Cannabis in Canada" from the Task Force on Cannabis Legalization and Regulation, public-health officials issued 112 pages of proposed rules for Canada's cannabis industry, stating, "We recognize that there will be much discussion around the implications of our recommendations. However, like scraping ice from the car windows on a cold winter morning, we believe that we can now see enough to move forward."

Cannabusiness owners are awaiting the final regulations, due to be issued sometime in February, before the recreational marketing rollout. Some wonder: Will the Canadian government take the fun out of legal marijuana?

Speaking to *Bloomberg*, Bill Blair, former chief of the Toronto Police Service turned marijuana "point person" for the Ontario government, said that the goal of strict official regulations is to "do a better job of protecting our kids." But that way of thinking is behind the times. Many nonmedical consumers are middle-aged or older. The cannabis industry's concern is that, if proposed restrictions limit traditional advertising methods, it may be difficult to market pot products to adult consumers.

To many cannabis consumers, the new laws may not make much of a difference. They'll buy and smoke weed no matter how it's packaged. In fact, true cannasseurs may not even *want* to buy legal weed. In many cases, provincial govern-

BLACK, GRAY AND GREEN MARKETS

Under Canada's federal pot laws, citizens ages 18 and older will be able to grow four plants of any size at home. However, most cannabis consumers want to buy their bud—it's much easier to leave growing great weed to the professionals. It remains to be seen whether marijuana aficionados embrace legal pot shops, or continue to buy from the guy who delivers the finest kind to their front door.

Steve is a marijuana delivery man operating in the hip Plateau-Mont-Royal neighborhood of Montreal. He feels

ments are choosing to contract with largescale growers to fulfill their legal cannabis quota, leaving little to no room for smaller operations growing high-quality bud. It may be difficult to find top-shelf nugs in retail pot shops if the supply is primarily from huge industrial grows.

Judging from the track record of US states that have legalized recreational marijuana, like Colorado, Washington and Oregon, the cannabis market in Canada will likely take years to develop. There will be unexpected setbacks. Officials will need to work closely with businesses and communities to fine-tune regulations and finances as obstacles and opportunities—crop up. certain that weed going legal in Quebec won't affect his job or company in the least. Steve works for an outfit that provides top-shelf nugs, pre-rolls, edibles and concentrates. Clients order via SMS text. An eighth of the best weed around goes for C\$30, delivered right to your home, Steve says. Why would any of his clients want to go to a giant governmentrun pot shop and pay more? Steve told HT, "[The government is] effectively granting a quasi-monopoly to a few corporations-and some of those corporations are run by former police officers who have been directly involved in the persecution of those who love the herb. A lot of people have a negative reaction

to that, along the lines of 'Fuck, I'm not buying my weed from a cop!'"

Steve continued, "Also, mass production like that is the Walmartizing of weed. It's McDonald's weed. It's not artisanally crafted, well-grown varieties. It's going to end up being the most commercially cost-effective varieties. Because of that, I think we'll be able to outcompete the big producers, both in terms of quality and in terms of service. From a customer standpoint, they take out their phone, they send a text, and somebody knowledgeable and polite shows up—that's going to trump going to a store and buying some pre-packaged whatever."

So trouble may be brewing. Licensed medical-cannabis growers and regulators could be pitted against the black-market weed industry, as everyone figures out how to pivot toward the recreationalmarijuana market.

While ganjapreneurs scramble to get ready for government oversight, one event is attempting to bridge the gap between illicit weed and legal cannabis. Green Market, a women-led pop-up farmers' market, occurs regularly in Toronto, and has expanded to other cities across Canada. The market hosts vendors selling all types of pot products—edibles, concentrates, drinks, topicals, flowers and more—to anyone 18 or older. With no medical recommendations needed, before legalization has taken effect, the event runs a risk in openly offering pot products for sale.

Cannabis activist Lisa Campbell, cofounder of Green Market, says that it's in business to address the supply gap between the current medical- and future recreational-cannabis markets. Campbell told *HT*, "Green Market started a year and a half ago, and we have another year to go after legalization until edibles and craft producers are included in legalization in 2019. Until then, Green Market has inspired a whole generation of craftcannabis makers and pop-ups across Canada!"

REC ON THE ROCK

Newfoundland and Labrador, the most easterly Canadian province, is in hard economic shape. After the collapse of the Atlantic cod fishery in the '90s, thousands of Newfoundland families struggled to make ends meet. There was a mass exodus from the outport fishing towns dotted around the island, and many young folks moved to mainland Canada to find their fortunes. Today,

despite a thriving tourism industry and offshore oil drilling, the province is still hard up. Will cannabis prove to be a cash cow on "the Rock," as it is in so many other places?

One man fired up about the possibilities that legal pot may afford him is Thomas H. Clarke (note the initials). Clarke grew up in Newfoundland's capital, St. John's, and started selling pot in junior high. He was arrested at 18 for trafficking hashish, though he wasn't actually caught with it-his buddy turned on him. Clarke was convicted on the basis of that statement and served 30 days in jail. "As a 19-year-old kid, that was pretty eye-opening. I didn't want to go back there, that was for sure," Clarke told HT. "But I made connections because I didn't turn on anyone." From there, he started selling quarter pounds and ounces, mostly to relatives and trusted friends. But he wasn't in it for the money, he said. "I was in it for the cheaper grass."

Clarke's grandparents were both activists-his grandmother received the Order of Canada-and his mother is an educator, so his path to becoming an advocate for legalization in Newfoundland and Labrador made sense. He told HT, "I began speaking up about it because I knew I had to, in order for the province to go in the direction that I felt it should: localizing the industry, letting small businesses open and hiring as many Newfoundlanders as we could." At 43, he has become the face of the marijuana movement in St. John's, appearing on TV and radio shows, working tirelessly to destigmatize weed. And much to his satisfaction, the province recently ruled that private retail shops will be able to carry cannabis products.

Now living in Portugal Cove, just eight minutes from the St. John's airport, Clarke is preparing to open up a retail pot shop on his property this summer as soon as he can get a license from the province. He has big plans for branding, planning an entire line of locally themed Blueberry strains repackaged to reflect Newfoundland culture. "I already have 13 strains picked out," Clarke confided.

Another St. John's businessman, Jon Whalen, told *High Times* that he believes there will be plenty of room for people like him to operate. Whalen, through his company Grass Hut Organics, plans to act as a broker between small operations growing top-shelf cannabis and retail shops. He's heartened by the fact that the provincial government is talking in

inclusive terms about bringing people into the fold from the black and gray markets, "making tax-paying citizens out of those who are already in the marijuana business one way or another." Whalen anticipates that it will be relatively easy for Newfoundlanders to get licenses for retail shops.

Though the Newfoundland government struck a deal last December with Canopy Growth Corp. to supply 8,000 kilograms of cannabis annually in the first two years of legalization, Whalen said that's only about a quarter of what Newfoundlanders actually consume. "There's a lot of weed smoke in Newfoundland," he says, laughing. "There's still a lot of room to supply. Otherwise, the black market will continue to fill in whatever blanks exist anyway. It's not really going to go over to the legal market until the people buying grass want to go to legal shops. I think it's going to be a while."

PEACE, ROOTS & CORPORATE CANNABIS

The Cronos Group investment firm owns and operates several licensed producers in Canada, including Peace Naturals in Ontario, where the company is in the process of building what chief operating officer David Hsu told *HT* will be "the largest purpose-built indoor facility in the world."

The Cronos Group is poised to take a major share of the legal cannabis market with several companies across Canada operating under its aegis. When the group bought Peace Naturals, which was established in 2013, it also acquired a seed bank containing over 150 unique strains. Eric Klein, head of marketing for the Cronos Group, said, "New LPs [licensed producers] generally have to procure genetics from existing LPs, so with Peace Naturals we have an advantage."

Cronos COO Hsu added, "We have over 19,000 seeds. Our ultimate goal is to find cultivars that are targeted for therapeutic relief. The main advantage of having such a large facility isn't just for production. I think a lot of people in Canada are narrow-sighted for the recreational market. The rec market is exciting, but we're very focused on the medicinal market and creating further intellectual property [in strains], better bioavailability, and then to get our genetics into clinical trials." Ultimately, Hsu said, the company wants its product labeled with a drug identification number (DIN). An eight-digit DIN, used on prescription and over-the-counter drugs in Canada, indicates that the product has undergone testing and passed a review of its formulation, labeling and instructions for use.

The Cronos Group also has a joint venture with the cannabis company Indigenous Roots, led by Phil Fontaine, former chief of the National Assembly of First Nations. Indigenous Roots will specialize in providing legal medical marijuana and jobs in the cannabis industry to First Nations communities. Speaking to reporters last year, Fontaine said that the new business venture is about helping Canada's indigenous peoples gain access to high-quality cannabis products. "We know this is an underserved population," Fontaine said. "Indian people deserve to have access to quality products."

THE TRUE NORTH, STRONG & FREE

As the federal government's legalization deadline approaches, it's still unclear what the new marijuana landscape will look like. Canadians will experience the impact and benefits of legal cannabis under various types of regulations coast to coast, from Newfoundland all the way to British Columbia. The rest of the world will be watching, and taking notes in anticipation of marijuana prohibition coming to an end in other countries all around the globe. Hopefully, that bright green future isn't too far off. *****



GROW WEST, YOUNG MAN


Ryan Jennemann fled from Tulsa, OK, to Los Angeles with a dream to grow pot in relative freedom. He had seen how medical cannabis helped his ailing father with debilitating headaches and how the lack of it contributed to his dad's demise at only 47 years old. The ongoing harassment, persecution and prosecution of his family by Oklahoma law enforcement led him to seek greener pastures out West. Now he's a co-founder and the chief cultivator for THC Design, overseeing all of the company's growing facilities and ensuring that the medicine it produces is as clean and as effective as possible.

From the moment I meet Jennemann and his crew, I realize there's a palpable emphasis on family. Jennemann's brother Seth is THC Design's president and CFO, and much of the company's staff are trusted friends from Oklahoma who migrated out to California to be a part of the team. Seemingly every worker I encounter on my tour looks happy to be there and shares with me a pride in being a part of the company and community.

The facilities at THC Design capture, reclaim and reuse between 1,500 and 2,000 gallons of water per day from dehumidifiers and central air conditioning. The growers follow strict Oregon Tilth organic standards, which are much more stringent than federal OMRI certifications. THC Design's focus on renewable resources is driven by a constant desire to reduce its carbon footprint, and the company has increased its energy efficiency by 40 percent over the last four years.

THC Design also provides a unique veterans-outreach program, hosting a 12-week paid internship for retired military members to learn the various aspects of the cannabis-growing





business. I asked Jennemann why the company has gone out of its way to hire vets. "Well, first off, I think they're good people and hard workers, and I have a tremendous amount of respect for their achievements," he says. "I've hired people in the past and then watched them come in at least a half hour late every day, complaining about the traffic, acting entitled. Veterans are not that way at all. They are here on time and to work. Their training and experience make them dependable, trustworthy and able to meet obligations and accomplish demanding tasks. There's always something to do here, and the vets we've brought in inherently understand that."

It certainly helps the company's public relations to reach out to ex-military people, but it also sounds like it helps the bottom line. "Veterans are an amazing untapped talent pool," Jennemann says. "So in addition to giving back to those who have done so much for us, our internship program also makes great business sense."

Jennemann certainly puts his money and his effort where his mouth is. Unlike some producers, THC Design advocates full legalization of cannabis and supports the National Cannabis Industries Association, Americans for Safe Access, the California Growers Association, the Drug Policy Alliance and many other superb law-reform organizations. Jennemann meets with legislators and plays an active role in community relations, and THC Design has programs in place for outreach to seniors, the LGBTQ community and those who live on skid row. The company hosted the first cannabis booth at DragCon and the first cannabis float at the Long Beach Pride Parade.

THE GROW

The main THC Design facility I'm visiting boasts a total of 20,000 square feet. Nine flowering rooms, each 1,000 square feet, are timed so that each week a different room is ready to be harvested. Each room is lit by 27 1,000-watt Gavita lights with a footprint of 35 square feet per double-ended HPS (high-pressure sodium) bulb. Rolling trays hold the plants and can be moved easily so that workers can reach every area of the room. Moisture-monitoring sensors are installed in each zone to ensure proper humidity levels.

Mother plants grow in a soil mix and are fed aerated-compost tea. They're lit by 315-watt LEC CMH (ceramic metal halide) bulbs (with plans to switch over to new, more efficient 600watt versions) and pampered with tender loving care by a crew of devoted workers. The company's even experimenting with utilizing aquaculture, with an 800-gallon tank growing carp. Black soldier fly larvae feed the fish while the waste from the carp feeds the moms. The plants get nitrogen from the fish and calcium and magnesium from the flies! Using fish guano instead of bat guano also protects bat caves from overharvesting.

The nursery for clones is kept at 80-86°F with 80 percent relative humidity in order to replicate the natural spring planting season. Clones are cut from healthy mother plants, dipped in rooting hormone and then gently placed into rockwool cubes. Once rooted, they're ready for the next stage: vegetative growth.

Rooted clones are transplanted into a mix of coco coir over perlite as they begin the vegetative stage. Containers are covered with FloraFlex caps and drip-fed with Mills Nutrients Basis A and B as the base. Tea brewers are employed to steep Bokashi compost teas as well.







WATERING AND FERTIGATION

Previously, THC Design discovered fungal growth in some of the reclaimed water from the HVAC systems and dehumidifiers. To eliminate it, the company uses inline UV lighting in the ducting and air handler in order to sterilize the liquids, a system similar to what's employed in hospitals. Today, more than two-thirds of the water used at THC Design is reclaimed a significant reduction in the company's water footprint.

This unique watering system rivals any l've ever witnessed. In addition to the UV lighting in the ducting and master reservoir, a mesh filter is used on the incoming condensate line from the HVAC to the reservoir to filter out any particulates.

Each vegetative and flower room has its own reservoir that's mixed twice per week. The moisture-monitoring sensor in each zone triggers the water pump to irrigate just that zone when necessary. In the vegetative stage, watering is limited to two hours after the lights come on and no sooner than four hours before they go off. During flowering, watering starts four hours after lights come on and ends four hours before they're turned off. All excess water is recaptured and filtered for reuse.

This leaves just a four-hour window in the middle of the "day" for nutrient solution, and Jennemann has found this to be the best way to ensure the perfect moisture capacity in the Left: Massive tanks collect and reclaim water. Top Right: Individual droppers maintain moisture at root level. Bottom Right: Filtration is essential to water purity. medium for rapid root and plant growth. The wet/dry cycle encourages tremendously healthy plants that yield huge colas. The closer the plants get to flowering, the more the medium is allowed to dry out before watering again. Jennemann tells me that dialing in this "plateau in the irrigation window" for each individual strain is the key to heavy harvests of buds saturated in essential oils. The balance between what he calls the "nurturing and torturing phases" produces glandular trichomes swollen with terpenes, cannabinoids and flavinoids.

Plants go through a 22-day vegetative stage before they're induced to begin their 56-63 days of flowering. No synthetic plant-growth regulators (PGR) are used at any time. THC Design's integrated pest management (IPM) consists of foliar applications of Regalia biofungicide, Venerate bioinsecticide, activated aerated tea, Big Time Exterminator and kelp hydrolysate. Additionally, garlic, lemon and fish oil, along with natural enzymes and bacteria, are used to combat pests before they get a foothold and before extreme measures even need to be considered.





THE HARVEST

THC Design's flowering rooms are timed to be harvested one room per week. After an aggressive weeklong flushing period using only plain water on the plants, they're finally ready to crop. Every Wednesday, the THC Design harvesting team takes down an entire 1,000-squarefoot room, managing to process an average of 2.7 pounds per light. That's more than 70 pounds of dry flowers per week, and yet each flower is trimmed entirely by hand. "We take our time with the harvesting process," Jennemann says. "It takes us 10-14 days to dry the whole plant with the fan leaves left on and all. A dry trim using workers with scissors is labor-intensive and costly but well worth it for the quality we achieve in the end."

THC Design's drying-room philosophy is simple. Cool air keeps the smell down and preserves volatile oils. The air conditioning is set at 70°F, a humidity fogger at 60 percent and a dehumidifier at 55-58 percent. It reminds me of that old Steven Wright joke: "For my birthday I got a humidifier and a dehumidifier... I put them in the same room and let them fight it out." Either way, drying slowly in cool conditions kept at the optimum level of humidity results in a flawless flower that perfectly captures the potential of each cultivar grown at THC Design.

Post-harvest, each flowering room

is cleaned thoroughly with hydrogen peroxide from top to bottom. Only then, with the area empty and devoid of plants, sulfur is burnt to discourage outbreaks of powdery mildew (PM). After the sulfur dissipates, the rooms are repopulated with vegged-out plants and the whole process begins again.

All of this hard work pays off in the creation of a product that's top-shelf, even though it's produced in large quantities. The quality also extends to the packaging, with eighths and pre-rolls provided in classic tins and containers worthy of a high-end premium product, along with Boveda packs for humidity control and preservation. The pre-rolls come as six artisanal cones totaling 3.5 grams per box with independent test results included.

I leave THC Design impressed with the fact that at least some cannabis growers are at the forefront of creating "greener" weed. With cultivation inevitably getting bigger and more corporate, it's inspiring to see people at large facilities concerned about reducing their carbon footprint and engaging with their communities and legislatures. Besides that, it's clear that the cannabis THC Design produces in large quantities is clean, flavorful and potent. Let's hope more large-scale cultivators follow its lead. $\frac{1}{2}$





This 84-year-old living legend has been writing and performing country music since the late 1950s. Willie Nelson has also championed farmers with his Farm Aid festival. promoted sustainability by putting his money where his mouth is by traveling by biodiesel bus, and co-chaired the advisory board of the National Organization for the Reform of Marijuana Laws (NORML). In 2014, he started Willie's Reserve to provide his signature cannabis strains as well as edibles, vapes and accessories in Washington, Colorado, Oregon, Nevada and, most recently, California.



MELISSA ETHERIDGE

Iconoclast. Cannabis advocate. Melissa Etheridge is a woman of innumerable talents. Nominated for 17 Grammy Awards (she took home two), Etheridge won an Academy Award in 2007 for Best Original Song, "I Need to Wake Up," written for the documentary An Inconvenient Truth. She discovered the medical benefits of cannabis when she was battling breast cancer, and has since been an outspoken advocate for legalization, along with her tireless activism for LGTBQ rights. Etheridge is creating a line of cannabis products through her company Etheridge Farms.



B-REAL

OG weed rapper B-Real has become a staple of California's legal cannabis industry, releasing Cannabis Cup-winning strains and partnering with ROOR for Phuncky Feel Tips. B-Real is also a tireless legalization advocate, speaking out about the benefits that a fully legalized marijuana industry can offer. High Times named him "Stoner of the Year" in 2014, and he was one of the cannabis legends on the Mount Kushmore cover. He's currently tearing it up with his new supergroup Prophets of Rage. Catch B-Real smoking with all kinds of celebs on his show The Smokebox, airing on his live streaming network, the video and news site B-Real TV.



DOUG BENSON

This stand-up comedian and podcast pioneer has been advocating for marijuana-law reform and the rights of cannabis consumers for over a decade. In 2004, Benson co-created and performed onstage in The Marijuana-Logues with friends Arj Barker and Tony Camin. His 2007 film, Super High Me, documented his use-and non-use-of marijuana. He hosts the popular podcast Doug Loves Movies and a weekly YouTube show called Getting Doug With High, during which all guests consume cannabis at 4:20.



DAMIAN MARLEY

The youngest son of reggae legend Bob Marley has been performing since he was 13 years old. Now the multiple Grammy-winning Damian Robert Nesta "Jr. Gong" Marley uses his music and his business acumen to send a message championing cannabis and hemp. With his cannabis company Stony Hill recently launching a line of CBD products, he's also partnered up with Ocean Grown Extracts to grow marijuana in an abandoned prison and he's joined a group of investors who've bought your favorite weed magazine-High Times!

JOEY DIAZ

This comic got his start performing stand-up in front of fellow prisoners at a correctional facility in Denver in 1988. Since then, Joey "Coco" Diaz has been touring regularly, acting in films and television, and appearing as a regular on Joe Rogan's podcast, often discussing his love for marijuana edibles. He also hosts his own biweekly podcast, *The Church of What's Happening Now*, and airs inspirational and hilarious "Morning Joint" pot-friendly broadcasts on Periscope.

BILL MAHER

Bill Maher has been a mainstay on late-night television for 25 years, first with Politically Incorrect (1993-2002) and now with the Emmy-nominated Real Time with Bill Maher (since 2003). An unapologetic proponent of cannabis, Maher has used his voice to advocate for marijuanalaw reform, often discussing the subject on air. He is an advisoryboard member of the National Organization for the Reform of Marijuana Laws (NORML) and was named the number-one pot comic by High Times magazine.



SNOOP DOGG Snoop Dogg's image is now synonymous with marijuana. He has graced the cover of High Times four times, including as part of the legendary Mount Kushmore gang. And Snoop is not only an OG weed rapper-he's a legit cannabis businessman. Reggie Watts is an internationally renowned vocal artist/beatboxer/ musician/comedian who wows audiences with his 100 percent improvised live performances. Using his formidable voice, looping pedals and vast imagination, Watts blends and blurs the lines between music and comedy. Tvert has also joined forces with Colorado-based VS Strategies in hopes of sharing lessons and implementing strategies to help cannabusinesses. trade associations and state governments better understand the complexities that come with legalization.

ROZ MCCARTHY FOUNDER & CEO, MINORITIES FOR MEDICAL MARIJUANA

As the founder and CEO of Minorities for Medical Marijuana Inc. (M4MM), she is responsible for the organization's day-today operation and is the chief strategist involved in developing advocacy, education and marketing campaigns to promote awareness, information and education about the efficacy of medical marijuana. M4MM is a membership-based organization working hard to ensure people of color have a true quantifiable opportunity to participate in the medical-marijuana marketplace and are afforded adequate access to care, no matter what their economic situation.

SHANEL LINDSAY FOUNDER & PRESIDENT OF ARDENT

Shanel Lindsay helped create Massachusetts's adult-use pot law, and she sits on the state's Cannabis Advisory Board. But this attorney's passion is for helping medical-pot patients get the most out of their medicine. As such, the founder of Ardent LLC created the NOVA Decarboxylator, which helps prepare cannabis for infusions, simply and consistently. Lindsay advocates for medical pot and emphasizes the need to educate the public in order to make marijuana an accepted treatment for a variety of conditions.



DENNIS PERON CO-AUTHOR, PROP 215

Few figures in the cannabis world loom as large as Dennis Peron. Known as the "father of medical marijuana," Peron worked tirelessly on behalf of medical-cannabis patients. In fact, the system of state-sanctioned medicalpot programs that now exist in more than half the country can all be traced back to Peron, who co-authored California's medical-cannabis law (the country's first), in 1996. (As this issue went to press, we learned of the unfortunate passing of Peron, who died at the age of 71. He will be greatly missed by the cannabis community and the innumerable patients whose lives he touched.)



NINA PARKS CO-FOUNDER OF SUPERNOVA WOMEN

Nina Parks helped found Supernova Women in 2015 to provide a space for women of color in the ever-changing cannabis movement. With a mission based in education, Parks's organization fosters community empowerment and creates advocacy training and education through cannabusiness workshops and networking. Sparking change and opportunities for women of color has led Parks to speak up for would-be Oakland ganjapreneurs and to work to revise the current medical-pot program.

EBELE IFEDIGBO CO-FOUNDER OF THE HOOD INCUBATOR

For all the good the legal cannabis industry has done, it has also ultimately taken work away from the growers and sellers who made a living in the illicit market. As co-founder and co-director of the Hood Incubator, Ebele Ifedigbo is working to help such underground cannabis entrepreneurs transition to legal markets. Ifedigbo is passionate about racial and economic justice and advocates for those who have been disproportionately affected by the War on Drugs.

BILL PIPER THE DRUG POLICY ALLIANCE

Bill Piper's sole focus is ending the nation's misguided War on Drugs. As senior director of the Drug Policy Alliance's office of national affairs, Piper uses his nearly 20 years of political experience in Washington, DC, to lobby Congress in support of drug-law reform as well as fighting federal interference in state-sanctioned marijuana programs. Piper is also one of the most prolific reformers in the country, with his commentary and analysis appearing in publications throughout the country and around the world.



SEAN KIERNAN PRESIDENT OF WEED FOR WARRIORS

After serving four years in the US Army airborne infantry, Sean Kiernan had a successful career as a Wall Street hedgefund manager until he began to suffer emotional trauma from his time in the service. With heavy pharmaceuticals and the VA failing him, Kiernan turned to cannabis and was able to stop taking all other meds. As president of Weed for Warriors, an organization that advocates for the right of veterans to choose cannabis, Kiernan helps to provide services, counseling and even free cannabis to qualifying veterans

KEITH STROUP FOUNDER OF NORML

High Times May 2018

For those with any knowledge of the cannabis world, Keith Stroup is a household name. Stroup is the founder of the National Organization for the Reform of Marijuana Laws (NORML) and serves as legal counsel for the organization. Since founding NORML in 1970, Stroup has been a force in the reform community. After nearly 50 years, he is still lecturing, writing and advocating on behalf of his life's passion, cannabislaw reform.

NEILL FRANKLIN EXECUTIVE DIRECTOR OF LAW ENFORCEMENT AGAINST PROHIBITION

Maj. Neill Franklin was one of Maryland's top cops when he retired in 2010 after 34 years in law enforcement. Over the course of those threeplus decades, he went from being an active supporter of the War on Drugs to a staunch opponent. While serving as a narcotics agent with the Maryland State Police, Major Franklin was persuaded by the then mayor of Baltimore. Kurt Schmoke, who declared that the War on Drugs was counterproductive and created excessive violence. He retired from policing in 2010 to lead the Law Enforcement Action Partnership as executive director. When not working with LEAP, Major Franklin volunteers his time by serving on many boards, including Murder Victims Families for Reconciliation, the Faith **Based Community Council** on Law Enforcement and Intelligence and the Place of Grace Church.



They have bagged scores of Cannabis Cups and hundreds of other awards, and were early inductees in the High Times Seed Bank Hall of Fame, in 2009. While still killing it with their seed company, they also run a thriving consulting business, sharing their expertise around the world.



ARJAN ROSKAM FOUNDER OF GREEN HOUSE SEED CO.

Calling yourself the "King of Cannabis" would be a presumptuous affectation for almost anyone in the world—but not for Arjan Roskam, founder of Green House Seed Co. in Amsterdam. For over 30 years, Roskam has scoured the remotest corners of the planet to collect and preserve cannabis landraces, a project that has given the world some of its most cherished strains. That honorable mission has been documented in recent years in the HBO/Vice series *Strain Hunters*.

Crockett Family Farms was launched in 2008 by the pseudonymous "Crockett," a grower from the Sierra Nevada mountains who had been raised in the secretive world of cannabis culture. Crockett's legendary Tangie and Strawberry Banana strains are beloved by tokers the world over. As perennial Cannabis Cup winners, it was a no-brainer to install Crockett Family Farms in the 2017 High Times Seed Bank Hall of Fame.



SCOTT REACH FOUNDER OF RARE DANKNESS

Scott Reach has been a leader in cannabis cultivation for over 15 years. He launched Rare Dankness and Europe-based Rare Dankness Genetics in 2011. Four years later, Reach built a state-of-the-art facility in Colorado that produces highend cannabis for both the medical and adult-use markets. Reach shares his expertise all over the world, consulting with start-ups looking to establish best practices in the industry.



NEEMA SAMARI CO-FOUNDER & COO OF CANNABIOTIX

Neema Samari brought a connoisseur's vision to his first big gig with Gold Coast Extracts and Collection. In 2015, he partnered with his best friend, Jeff Buchman, to launch Cannabiotix, a cultivation and extraction company in California and Nevada. THE GAME HAS CHANCED

Aside from revealing secrets of industry leaders, David Robinson, author of The Growers' Handbook, lends his expertise to a segment called Teachings of the Garden Sage. You can check out gardens, like the ones that make British Columbia's Kootenay region the Mecca of B.C. bud, on the latest episodes at growingexposed.com.


When Bryan Johnston began growing cannabis, it was the early '90s. He was using 1000 watt bulbs hung from the ceiling commonly referred to as "Donkey Dick" lights. During this period, British Columbia was becoming infamous for the highest quality bud on the planet and people were calling the province's crops "Beaster". A lot has changed in the 25 years since — including his setup and the base plant food he uses, thanks to Green Planet Nutrients.

A n environmentally conscious guy, Bryan says he remembers, back in the day running those 1000 kilowatt bare bulbs. Today, his indoor garden uses a smaller wattage but yields dramatically more per watt than ever before.

"Everything has changed. The game has changed,"


he says. "I'm running doubled-ended P.L. lighting with four Spectrum King 600-watt LED lights and doing a massive cross spectrum of light, running four 315-watt P.L. ceramic metal halides. So I'm totaling just under 4,700 watts and yielding on average, two pounds or more for every 1,000 watts of light." The most recent change to Bryan's garden wasn't in setup though, but to a new base plant food. Manufactured by Green Planet Nutrients, Dual Fuel is a highly concentrated, two-part formula that provides all the energy plants need without the need for calcium or magnesium additives. It's known for an easy application process which leaves less room for error.

've tried different brands but I've been using Green Planet's Hydro Fuel and got fantastic results, so when I went to my local grow shop and got some samples of Dual Fuel about two years ago, it wasn't a stretch to give it a try," Bryan says. "But on some level, any type of switch is a leap of faith as a grower. People who consume my product are used to a level of quality and I can't afford to give them anything less than the best."



for the switch was really easy and the first noticeable difference was that my plants became way greener than before and they stayed lush green into the later stages of flower. It's also cleaner and I don't have salt residue or buildup. Plus I'm getting better and faster yields, so I'm saving about a week overall on my crop. I've done the math on what it costs to run other brands and not only am I saving money but I'm having better results."

With Dual Fuel, Bryan uses only three additives: Green Planet's Massive Bloom Formulation, Finisher, and Terpinator. He says when he's tested plants grown with the additives versus ones without, he's noticed way more cannabinoids.



Growing Lemon Haze since 2011, Bryan says this strain takes a little longer to flower than normal but the flavour and sativa experience is well worth it. He finds it easy to grow and the resulting product very consistent in quality.. With the switch to Dual Fuel, Bryan says he noticed changes to his plants almost right away.

Famously, he helped create the amendment known as Rohrabacher-Farr (now Rohrabacher-Blumenauer), protecting medical-cannabis patients and prohibiting the Justice Department from spending funds on prosecuting in legal states. A tireless supporter of the cause, Rohrabacher has pot smokers' backs in the tumultuous climate created by the current administration.



EARL BLUMENAUER US REPRESENTATIVE, OREGON

Congressman Blumenauer is a longtime supporter of ending the failed War on Drugs. He's called on Congress to reschedule, tax and regulate cannabis; allow for the cannabis industry to bank and operate in a normal business environment; and ensure safe access for patients—especially our veterans. In 2013, Blumenauer, along with Jared Polis (D-CO), wrote "The Path Forward: Rethinking Federal Marijuana Policy," a straightforward report outlining everything from current issues with federal and state pot laws to removing the ban on industrial hemp.



Under his leadership, Los Angeles lawmakers unanimously backed a host of new regulations for the adult-use cannabis industry. Wesson urged the LA City Council before the vote to "make history."



JARED POLIS US REPRESENTATIVE, COLORADO

In an uncertain political climate, it's impossible to overstate the importance of a staunch and ferocious ally. Fortunately, the cannabis community has such a supporter in Representative Jared Polis. As a member of the House of Representatives since 2009, Polis has worked to end the government's War on Drugs and to legalize cannabis. He's introduced legislation that would remove marijuana from the Controlled Substances Act and launched the **Congressional Cannabis Caucus** in 2017 to develop a rational approach to federal pot policy. Polis will run for governor of Colorado in the 2018 election.



GAVIN NEWSOM LIEUTENANT GOVERNOR OF CALIFORNIA

The lieutenant governor of California is one of the hottest up-and-coming politicians in the country. An early supporter of the Golden State's adult-use cannabis law, Proposition 64, Newsom supports marijuana legalization and has pushed back against the Trump administration's federal cannabis crackdown. Newsom has broad support from the cannabis community for the 2018 gubernatorial race in California, and many expect a run for the White House will be next on his list.



CAT PACKER EXECUTIVE DIRECTOR OF THE LOS ANGELES DEPARTMENT OF CANNABIS REGULATION

Appointed by LA Mayor Eric Garcetti in 2017, Cat Packer serves as the city's first executive director of the Department of Cannabis Regulation. Packer was the California policy coordinator for the Drug Policy Alliance (DPA), where she worked to ensure the successful and equitable development and implementation of California's evolving cannabis laws and policies. Packer championed responsible regulation, industry diversity and reinvestment in communities most harmed by marijuana prohibition.

SUBJECT: Feminized or Regular Seeds FROM: Jake the Muss

If you were going to start a grow op and had to choose between using only feminized seeds or only regular seeds, what would you choose and why? What are the disadvantages of feminized seeds?

Dear Jake,


My preference is always to grow from regular seeds. In my opinion, you'll get hardier and more potent plants from regular seeds as long as they're purchased from a reputable seed bank in their original packaging. If this is a sizable grow op rather than a closet, tent or grow box, then you should definitely grow from clones that are taken from a female plant grown from regular seeds.

The key to achieving this is to grow out plants from regular seeds in order to select a mother plant from them. In order to know the sex of your regular seed plant, you must take a clone from it and flower the clone. This way you know the sex and traits of the corresponding parent plant without having to flower the parent plant itself.

Pick the strongest female from the clones you flowered from your regular seed plants and discard the males and unchosen females. Your vegging female mother plant is now ready for you to take clones from in order to fill up your grow op. The benefits of this are that the plants will all behave in the same way, with a level canopy that you wouldn't get growing from seeds.

The disadvantages of growing from feminized seeds is that you only grow them once and the plants lack the vigor of those grown from regular seeds. The advantage is that you don't have to cull the males. Feminized seeds are also more prone to hermaphroditism, so you have to keep a close eye on them.

Danko Tip: Aerate all hydroponic reservoirs with an air pump and air stones to increase oxygenation and keep nutrients well mixed.



SUBJECT: **CBD Strains** FROM: **Green Flash Farms**

Aloha. I grow outdoors in Hawaii, and my patient has requested that I grow a high-CBD strain like Cannatonic or something from the CBD Crew. My question: Are any of these strains stabilized enough for a backyard grower to work with them and be sure the plant has a high CBD ratio? With little access to testing, can we as growers be sure that these strains are what are claimed, or is there a chance that some phenos will not be high in CBD? I don't want to give a patient medicine that isn't what it's supposed to be.

Dear GFF,

You can trust that any seeds you buy from the CBD Crew (*cbdcrew.org*) will contain CBD (cannabidiol), a cannabinoid credited with many medical properties such as reducing the frequency of seizures. The CDB Crew is at the forefront of research into breeding CBD-rich marijuana varieties and its strains are stable and grow true to form. There are certainly also other reputable breeding outfits out there that also sell high-CBD strains as well.

You can now have your strains tested at Steep Hill Labs in Hawaii as well. The most important thing to remember about cannabis as medicine is to use a "whole-plant medicine" approach. The benefits of CBD are greatly increased when used in conjunction with other cannabinoids, including THC. This "entourage effect" is the foundation to understanding how medical marijuana works.

The key to utilizing CBD to its utmost effectiveness is the study of the ratios between CBD and THC. Different patients find relief for a variety of symptoms from cannabis with certain ratios, and this is the reason why "CBD-only" medicine and legislation aren't good for the future of medical usage of marijuana. Don't even get me started on the Chinese "hemp paste" being sold as medicine by multilevel marketers to desperate people in states without medical-marijuana laws.

SUBJECT: Contamination From Hermaphrodites FROM: Mike C.

If I have a hermaphroditic plant in my outdoor garden, can it pollenate the rest of my crop?

Yes, indeed. A hermaphroditic plant has the potential to seed your entire garden indoor or out. This is why it's so important to get your initial seeds or clones from a reliable source. Growing out and holding on to your own mother plants is



the only true-tested way to avoid the dreaded hermaphrodite.

Hermaphroditic plants are those that exhibit the sexual organs of both males and females. It's easy to spot males but much tougher to discern a female with some male flowers interspersed. These are the "hermies" that can ruin a whole crop, and they must be removed from the garden immediately and destroyed. Keep in mind that there are some strains that only show these types of symptoms very late in flowering (particularly from Southeast Asian genetics such as Thai), but they can still be deemed keepers due to the fact that it happens close to harvest and the premature males don't have time to do any damage.




SUBJECT: Cal-Mag Deficiency FROM: KC

I believe my plant has a calcium/magnesium problem. The leaves started to develop brown splotches on them, and within a day they went from healthy to curled and crispy (the edges break off at the touch). The light is more than far enough away and the temperature hasn't gone past 81°F. I ordered some Cal-Mag, but I'm not sure if they're going to survive that long. Should I cut off the fan leaves at this point? My other plant that's in the same bucket is doing well and hasn't shown any splotches yet. Both plants have been cleared of growth tips and fan leaves below the forth node, and the one with the problem has been topped once.

Dear KC,

It seems that you've diagnosed your problem correctly. The only other reason your plants could be exhibiting the symptoms of a nutrient deficiency would be a pH imbalance. When the growing medium or nutrient solution is too acidic or alkaline, roots can't take in certain nutrients, even when they are present.

If pH is within the proper parameters, then add the Cal-Mag you ordered and your problem should slowly go away. Remove and discard any dead or dying leaves from your plants, but try to keep all healthy green growth intact.



SUBJECT: Let's Get Started FROM: Siddharth C.

114 DEAR DANKO

I have to start my pot production on a small scale. I can't get my hands on rockwool or expensive fertilizers. In fact, I don't know anything about growing. If you could guide me through the process, it'd be a real help. Can you answer these questions?

What type of soil can I grow in? Is loamy soil okay? How many days does it take for a plant to grow fully? Do I have to water it like a simple plant? Can I get it growing without the pH trouble?

Dear Siddharth,

You can surely grow cannabis without rockwool or expensive fertilizers. The best soil for growing is a light and airy mix that goes from wet to dry quickly. Loam is a combination of sand, silt and clay that's actually quite ideal for growing.

Cannabis takes a minimum of 70-90 days to up to 6 months or more to complete its life cycle from seed to harvest. Autoflowering and *indica*-dominant strains finish on the shorter side, while *sativa*-dominant plants will take longer. Outdoor plants will grow in their vegetative state from spring into summer and flower in the fall. Indoors, you control the length of the vegetative time with a light timer.

You do water it like a simple plant, but you must add plant food in the form of nutrients to your water in order for the plant to thrive and flower properly. You should test for pH and try to maintain the pH of your soil and watering solution between 6.0 and 6.8.

SUBJECT: Vegetate in Flowering Area FROM: Brian

2 I always find your articles to be a big help and was hoping you could answer a question for me. I am a medical user in a not-so-friendly state, and as such the only way to get anything with both CBD and THC is to grow my own. I need to grow a little bit more than I am growing right now, but I'm maxed out on my current grow space. I grow from seed in a ScrOG setup 2-3 plants at a time. Due to variances in phenos, I always wind up with a plant that takes an extra 2-3 weeks or so to ripen and get cut down. This leaves me with a lot of unused grow space for almost a month each grow. I was wondering if I could germinate and start my next seedlings during this time. The lights would still be 12/12 for finishing off the other plants (or would they?), so I was wondering what effect this would have on the seedlings? I know that in nature most plants germinate around the spring equinox, which is 12/12, so I do not see an issue—but I do not know and cannot afford to possibly lose an entire grow cycle of my meds to test this theory out. Your thoughts and suggestions would be great. Thanks!

Dear Brian,

Plants need more than 12 hours of light in order to stay in their vegetative stage. The only way you can accomplish what you're trying to do is to give your seedlings more light than your flowering plants. You could either take them out of your flowering space during the dark time when the lights are off and provide them with light, or you can separate your grow chamber into two spaces, one for vegetative growth and one for flowering. *****

It was our brainchild. Michael Hiller (managing partner) and I attended a few meetings of the New York Cannabis Bar Association, consisting of a group of lawyers who sought to challenge New York's overly restrictive medical cannabis regulations. In thinking through various potential causes of action for that case, we realized quickly that the strongest claims were constitutional in nature, should be lodged against the Federal government, and belonged in Federal Court. We then thought through all of the different ways that individuals and businesses are "damaged" or suffer with "irreparable harm" as a result of the unconstitutional classification of cannabis as a Schedule I drug, reached into our personal networks, and found our plaintiffs.

How do you address the argument against children using medical marijuana?

It really depends on the condition at issue, but I would encourage them to step outside traditional comfort zones, talk to physicians who specialize

It's no secret that Cannabis companies have faced unfair roadblocks over time, especially when it comes to raising capital using the traditional methods.

And they aren't alone in these difficult circumstances. But with some creativity and innovation in the cannabis community, new concepts are being adapted and developed that will change how companies raise money.

The most exciting new idea is the ICO, or Initial Coin Offering.

Companies use ICOs as way of selling investors up front participation in an "economy," generally at a discount, that allows them to benefit from future gains on a digital, Blockchainbased currency.

As Don and Alex Tapscott, authors of 2016's *Blockchain Revolution*, put it:

"The Blockchain is an incorruptible digital ledger of economic transactions that can be programmed to record not just financial transactions but virtually everything of value."

Economies and markets built on Blockchain technology can function with a digital currency – or cryptocurrency – based transactions, with access to the currency initially launched through an ICO.

As Blockchain technology expands across the cannabis industry, new opportunities will be created for cannabis-focused cryptocurrencies.

For example, Alternate Health (CSE:AHG) has recently purchased a Blockchain-enabled mobile payments system to complement their CanaPass controlled substance management software. This technology ensures secure, transparent and trackable transactions in much the same way an ICO is used to raise capital.

At the end of the time limit or when the full number of tokens are sold, and the currency is live can be used for transactions. Investors can spend it, sell it or hold on to it for future gains.

Often this way of raising capital for Cannabis companies can be a more independent, transparent and quicker method for companies to get funding. For investors the important thing, as always, is to do your research to make the best of your investment in this dynamic industry.

The coins or tokens in question can appreciate in value just as stocks do in the public market, while the company making the offer generally uses the capital to fund their business. But unlike an IPO that offers a stake in the ownership the company itself an ICO sells a right of ownership or royalties to a project.

This technology ensures secure transparency with the potential to integrate digital currency transactions as the crypto-cannabis industry evolves.

Many ICOs are based on previously existing cryptocurrency like Ether There are a number of online exchanges, so do some research and sign up for an account with an exchange that support's your ICO of interest.

in treating pediatric patients with medical cannabis, and talk to parents, and the childrenwho rely on it. There's no harm in learning more, particularly when many of the medications medical cannabis can replace have disastrous, proven side effects.

Why is this case pivotal for the Canna?

We are at a tipping point, where more than half the nation believes cannabis should be legal and lives in a jurisdiction in which some form of cannabis is legal, California is on the verge of full legalization (which is the 5th largest economy in the world, after Brexit), the government has already declined to enforce the Controlled Substances Act against state-compliant medical cannabis businesses and individuals and has de-funded the DEA accordingly, sophisticated economies globally are recognizing benefits of legalization, and the campaign of misinformation has been largely debunked and overshadowed with promising research and success stories. The nation has been hurt and divided since last November, but the legalization of cannabis stands to unite everyone. From the left, we will address social justice reform and patient advocacy. And from the right, we will address states' rights, and our constitutional guarantee to be free from congressional overreach. The criminalization and stigmatization of cannabis is an injustice that makes no rational sense, and the American people are waking up to that.

What's overarching reason behind the lag in the nation-wide legalization of Cannabis?

Hearts and minds need to change, and education is the key. We've been suffering with a political campaign, rooted in racial animus, deliberately designed to mislead the American people with regard to the safety and medical efficacy of cannabis.

N JANUARY, JUST 12 days after US Attorney General Jeff Sessions threatened a renewed crackdown on state-sanctioned marijuana programs, Representative Barbara Lee of California, along with 18 co-sponsors, introduced the Marijuana Justice Act into the House of Representatives.

This bill is by far the most comprehensive piece of legislation ever introduced to end the federal government's war on marijuana and address the egregious damage this policy has wrought, particularly on marginalized communities.

RETROACTIVE JUSTICE

Initially introduced in 2017 in the US Senate by Senator Cory Booker of New Jersey, the Marijuana Justice Act is the first-ever federal bill that seeks to provide relief to those either convicted or currently incarcerated for federal marijuana crimes. Of course, the majority of marijuana-related convictions are made at the state and local level, but the mere prospect of creating this national expungement program should embolden state and local advocates and lawmakers to prioritize expungement as part of any future reform effort.

The bill would also allow all federal inmates currently serving time for marijuana-possession or -use crimes to petition the court for a resentencing, which theoretically would result in them having the rest of their time commuted.

PROACTIVE JUSTICE

This robust legislation not only removes marijuana from the Controlled Substances Act, but it also provides a path forward for the individuals and communities that have been most disproportionately targeted by our nation's failed war on marijuana consumers.

According to the ACLU, African Americans throughout the country are arrested for violating marijuana possession laws at nearly four times the rate of whites, while both ethnicities consume marijuana at roughly the same rate. One of the dynamic ways that the Marijuana Justice Act would work to reverse this disparity is by monitoring the states that choose not to legalize. Should one of those states not reduce the disparity in arrest rates, it would lose various federal funding streams.

Any serious policy wonk will tell you that one of the things that state lawmakers and law enforcement fear most is the loss of federal funding. By having a mechanism that would slash federal funding due to arresting marijuana consumers, lawmakers would jump over each meanor or felony convictions.

In addition to having the federal government withhold funding from offending states, the legislation calls for the withheld money to be redirected into a newly created "community reinvestment fund," which would be administered by the Department of Housing and Urban Development. This fund would specifically be used for job training, public libraries, community centers and health-education programs in communities that have seen the highest rates of racial arrest disparities.

Thanks to the leadership in the marijuana reform space by Senator Booker and Representative Lee, we now have a bill that looks to not only stem the problem of federal marijuana prohibition, but also to fight back.

Commenting during the bill's rollout, Representative Lee said, "I'm proud to introduce the Marijuana Justice Act bold, progressive legislation to address the legacy of racial bias in marijuana enforcement and to end the failed War on Drugs... It's past time that we take decisive action to right the wrongs from decades of misguided policies."

What else is on the Horizon?


